## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereafter called the 'MOU') is entered into on the **20<sup>th</sup> of December 2021** by and between

**Cauvery College, P.B. No. 17, Pandanda Subbamma Nanjappa Campus, Virajpet-571218**, represented herein by its **Principal**, hereafter referred as the **“First Party”**

AND

**Kodagu Welfare Foundation®, I floor, Gagan Complex, Panjarpet, Virajpet, Kodagu, Karnataka**, hereafter referred to as the **“Second Party”**

### WHEREAS:

- A) The First Party is a Higher Educational Institution named:
  - (i) **Cauvery College Virajpet**
- B) The First Party & The Second Party believe that collaboration and co-operation between themselves will help both to work towards the betterment of Student Community.
- C) The Parties intend to cooperate and focus their efforts on cooperation within the areas of their capability.
- D) Both parties desire to sign this MOU for advancing their mutual interests.
- E) Both parties are engaged in helping the students through Sports and Personality Development.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

**CLAUSE 1**  
**CO-OPERATION**

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within them. The Parties shall keep each other informed of potential opportunities and shall share information that may be relevant to secure additional opportunities for one another.
- 1.2 The First Party and the Second Party co-operation will facilitate effective utilization of their capabilities, providing significant inputs for the promotion of Sports and Life Skills.
- 1.3 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents as may be required to give effect to the actions contemplated in terms of this MOU.

**CLAUSE 2**

14. Expose students to various sport activities by giving them opportunities to exhibit their skills.
15. The budding graduates of Cauvery College, Virajpet, will be enabled to learn new skills in the sport of their choice and would promote them to pursue their passion.
  - a. The students
    - Students would be trained in sport of their choice by specialized trainees. They would be provided a platform to display their skills.

- b. **Skill Development Programs:** The Second Party to train the students of the First Party in the field of Life Skills.
- c. There is no financial commitment on the part of the First Party to take up any programme mentioned in the MOU. If there is any financial consideration, it will be dealt separately.
- d. Guide, advice and help students of the First Party to improve their lifestyle.
- e. To inculcate interest in the student fraternity to learn the techniques of Sports and Life Skills for better living.

### **CLAUSE 3**

#### **VALIDITY**

- 3.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms.
- 3.2 Both the Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.

### **CLAUSE 4**

#### **RELATIONSHIP BETWEEN THE PARTIES**


It is agreed that the First Party and the Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

Thus, after the preliminary discussion and understanding of the objectives, both the parties extend their support for Betterment of Rural Students. The First Party has taken the approval from Cauvery Education Society to confirm a memorandum of understanding between the Parties by facilitating to elevate our common objective of promoting Sports and Life Skills among the students.
